

WHAT DOES AXOS® DO WITH YOUR PERSONAL INFORMATION?

Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and income
- Account balances and payment history
- Credit history and credit scores

How?

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Axos chooses to share; and whether you can limit this sharing.

Who we are	
Who is providing this notice?	Axos Financial, Inc. and its affiliates (collectively, "Axos"), including Axos Bank, Axos Invest, Inc., Axos Invest LLC; and Axos Digital Assets LLC, except for such affiliates that provide their own notice.
What we do	
How does Axos protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
	We restrict access to your personal information to our employees who need to know that information to provide your products and services.
How does Axos collect my	We collect your personal information, for example, when you

What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account.
Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.
	 Our affiliates include companies with a common corporate identity or name.
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.
	Nonaffiliates we share with can include tax preparation companies, insurance companies, direct marketing companies, nonprofit organizations, other banks and investment firms.
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.
	 Our joint marketing partners include finance companies, mortgage companies, insurance companies and investment companies.

Other important information

You may have other privacy protections under applicable state laws. Axos will comply with these laws to the extent they apply. We may telephone existing customers with offers for additional financial products. You have the right to opt-out of this contact by calling 1-877-247-8002 to add your name to our do-not-call/contact list.

California residents only: We will not share your information with companies outside of our corporate family, except as permitted by law. We will limit sharing among our companies to the extent required by California law.

Vermont residents only: We will not share information we collect about you outside of our corporate family, unless the law allows. We will not share your credit information with our Affiliates without your consent, but we may share information about our transactions or experiences with you within our corporate family without your consent.

Nevada residents only: This notice is provided to you pursuant to state law. Nevada state privacy laws permit us to make marketing calls to existing customers, but if you prefer not to receive marketing calls, you may be placed on our internal Do Not Call list 1-877-247-8002. Nevada residents may also contact the Nevada Attorney General for opt out information by phone (775-684-1100); email (bcpinfo@ag.state.nv.us); or mail (100 N Carson St., Carson City, NV 89701).

Virginia residents only: Under Virginia law, we will not share information we collect about Virginia residents with companies outside of our corporate family, unless the law allows. We will limit sharing among our affiliates to the extent required by Virginia law. **Do Not Call Policy.** This notice is the Axos Do Not Call Policy under the Telephone Consumer Protection Act. We do not solicit via telephone numbers listed on the state or federal Do Not Call lists, unless the law allows. Axos employees receive training on how to document and process telephone marketing choices. Consumers who ask not to receive telephone solicitations from Axos will be placed on the Axos Do Not Call list and will not be called in any future campaigns, including those of Axos affiliates. **Call Monitoring and Recording.** If you communicate with us by telephone, we may monitor or record the call.
